Topic of the month – Retrospective Planning Applications

This month's topic is on the submission of a retrospective planning application. It is important to bear in mind that development carried out without permission is not automatically classed as unlawful. It may comply with Planning Policy and be acceptable. Carrying out development without the necessary planning permission is not illegal – it only becomes so when an enforcement notice has been served, comes into effect and has not been complied with. However, carrying out works to a listed building or erecting advertisements without the necessary consents is unlawful. The majority of retrospective applications are submitted with the aim of regularising development where the land owner did not understand that planning permission was required. Where there is development without consent, there can be issues for the owner of the land if they wish to sell, or on some occasions to insure the land. Sometimes the need for planning permission is not identified until this point.

When a retrospective planning application is submitted, it does not mean that planning permission will automatically be granted. The application will be treated in the same way as any other application. This gives statutory consultees, including parishes an opportunity to comment on the application. Those comments will receive the same weight as any other planning application. If the retrospective application is refused, the Authority can issue an enforcement notice which requires the applicant to put things back as they were or to carry out remedial works.

A person who has undertaken unauthorised development only has one opportunity to obtain planning permission after the event. This can either be by means of a retrospective planning application (under <u>section 73A of the Town and Country Planning Act 1990</u>) or by means of an appeal against an enforcement notice on ground that planning permission should be granted or the condition or limitation concerned should be discharged.

Commencement of Hearing Sessions into the Development Management Policies document

You may recall from previous bulletins that the PDNPA was preparing the draft Development Management policies. Following the submission of the Development Management Policies document to the Secretary of State, the appointed Inspector (Mr. Nick Palmer BA (HONS) BPI MRTPI) has confirmed that the **hearing sessions will commence on Tuesday 22 May 2018** and are expected to continue until Wednesday 30 May 2018.

The hearing sessions will take place in the Board Room at Aldern House (main offices of the Peak District National Park Authority) in Bakewell, DE45 1AE.

The Inspector has advised that any member of the public can attend this hearing; however the right to participate in the hearing extends only to those who have responded to the previous consultation stages with proposed changes to the Plan, in order to make it sound and legally compliant. The Inspector has been in touch with these respondents to ask whether they wish to put their views across at the hearing.

Mend our Mountains campaign

The Peak District National Park is working with the British Mountaineering Council (BMC) and other UK national parks in the Mend Our Mountains: Make One Million campaign, which aims to raise £1 million for vital path-repair projects across the UK.

In the Peak District National Park, £140,000 is needed to fund path repairs on the Great Ridge, between Mam Tor and Lose Hill, and a further £70,000 for a stretch of the Cut Gate bridleway – known as the Bog of Doom - on the Derwent moors.
