# **Pre-Planning Application Service –** Introduction of Charging Regime

From 1 April 2014 the Authority has introduced charging for Pre-Planning Application advice for some forms of development, but the majority of requests will still be handled without any charge, notably requests for advice on householder developments (alterations and extensions to houses).

The level, detail and nature of the advice that the Authority will provide will vary, depending on what is proposed and the level of detail provided with the request. In general, the more detail the request, the more the response. The costs will vary according to the complexity of the proposed development. ## **The Local Enforcement Plan**

The Authority has produced a 'Local Enforcement Plan' in response to the recommendation within the National Planning Policy Framework paragraph 207:

"Effective enforcement is important as a means of maintaining public confidence in the planning system. Enforcement action is discretionary, and local planning authorities should act proportionately in responding to suspected breaches of planning control. Local Planning Authorities should consider publishing a Local Enforcement Plan to manage enforcement proactively, in a way that is appropriate to their area. This should set out how they will monitor the implementation of planning permissions, investigate alleged cases of unauthorised development and take action where it is appropriate to do so."

The plan sets out what breaches of planning control are, explains how potential breaches can be brought to the attention of the Authority, sets out what may or may not be investigated and the priorities for investigation and action.
